Prerequisite courses, or equivalent

No prerequisite courses, or equivalent, demanded for this course.

Purpose & Intended learning outcomes

Understanding of how sexual and reproductive health and rights (SRHR) are shaped, and its effects on future generations is crucial for all researchers involved in global health, maternal health and many other areas related to health. This course will provide participants with practical and theoretical tools as well as background to review and carry out research in SRHR.

At the end of the course the student should be able to:

Knowledge and understanding

1. Describe and reason about the state of the art in SRHR, including global trends, progress, challenges and gaps in research

2. Explain how structural factors – including social, political, economic and ethical factors - influence SRHR

Competence and skills

4. Justify the application of qualitative and quantitative data and measurements in SRHR

5. Apply skills for successful interdisciplinary collaboration (eg. awareness of different perspectives on SRHR)

6. Demonstrate skills in reviewing and critiquing scientific papers, e.g. provide feedback

Judgement and approach

3. Examine SRHR Policies and their relation to SRHR outcomes, as well as ways to translate research into policy

Course content

1. Introduction to core concepts and state of the art in SRHR in a global context

- 2. Underlying causes of (in)equities in SRHR
- 3. Intercultural and interdisciplinary academic collaboration
- 4. Scientific societal outreach

5. Sustainable Development Goals and other policy initiatives and their relation to SRHR globally

6. Critiquing the literature in SRHR

Forms of teaching and learning

This course is fully online. Learning activities will include online lectures, joint readings, panel debates, group discussions, production of a policy brief or pod cast and individual assignments. We will encourage maximum collaboration between the students from the different institutions.

Compulsory components

All collaborative/group work sessions are mandatory. In exceptional circumstances it might be possible to compensate for absence from mandatory sessions by performing an additional assignment if this agreed beforehand with the course leader.

Contribution to the discussions during the seminars

Forms of assessment

Formative assessment of the contribution to the discussions during the seminars

Summative assessment of:

- a written Reflective Diary for each of the teaching and learning activities. This should include what the students take with them and how this relates (or not) to their reasoning about SRHR research.

- a pod cast/policy brief produced by each participant during the course
